

**A BILL FOR
ORDINANCE NO. 16 SERIES OF 2023**

AN ORDINANCE AMENDING CERTAIN WATER RATE SCHEDULES SET FORTH IN THE CITY'S WATER CODE RELATIVE TO WATER SERVICE PROVIDED BY THE CAÑON CITY WATER DEPARTMENT, A WATER ACTIVITY ENTERPRISE

WHEREAS, based on a Rate Study completed in 2017 evaluating projections of revenues and expenses for the City's Water Activity Enterprise, it is necessary for the City to incrementally increase water rates to cover increasing operational and capital costs;

WHEREAS, the City further recognizes the need to provide enough revenue to allow future capital improvements to the City's water system including the City's 2A Street Improvement Project;

WHEREAS, the City Council is authorized to adjust such fees by Section 13.08.250(A) of the Cañon City Municipal Code; and


WHEREAS, the City finds that an incremental rate increase is in the best interests of the citizens of the City.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF CAÑON CITY:

Section 1. Appendix 13.08 of the Cañon City Municipal Code is hereby amended by the adoption of new water rate Schedules D, E, F, G, H, I, J, K, L, N, and O as attached in **Exhibit A**.

Section 2. Severability. If any section, subsection, paragraph, clause or other provision of this Ordinance for any reason is held to be invalid or unenforceable, the invalidity or unenforceability of such section, subsection, paragraph, clause or other provision shall not affect any of the remaining provisions of this Ordinance, the intent being that the same are severable.

Section 3. Effective Date. Pursuant to Article XII, Section 3 and Section 5 of the Charter, this Ordinance shall be effective January 1, 2024.



Schedule D: Inside Residential Rates

As provided in Section 13.08.050 and Subsection 13.08.060A, on and after January 1, 2024, the owner of each water service connection making water service available to a residential structure (and/or other permitted residential accessory structure or use) shall pay on a monthly basis the Meter Charge as provided for in Part I of this schedule and for water consumption according to the rates set forth in Part II of this schedule.

Schedule K: Golf Course Rate

Effective January 1, 2024, unless otherwise agreed in writing or required pursuant to contract, Shadow Hills Golf Club and Four Mile Ranch Golf Course shall pay a monthly Meter Charge as provided for in Part I of this schedule and for water consumption according to the rates set forth in Part II of this schedule.

Note: In addition to water consumption charges billed and payable in accordance with the foregoing base rate, Four Mile Ranch Golf Course shall be billed for and pay zone surcharges respecting such consumption calculated in accordance with the applicable zone surcharge rate set forth in Schedule P.

This table replaces and supersedes Schedule K to Appendix 13.08, as adopted through Ordinance No. 16, Series of 2023, with respect to water consumed on and after January 1, 2024.

Schedule L: City Rate

Effective January 1, 2022 and as contemplated in Section 13.08.080C of the Cañon City Municipal Code, this water rate shall apply to all water delivered by the Water Department to any park, cemetery, green space, public building, public facility or public grounds owned, operated and maintained by the City of Cañon City for the benefit of the inhabitants of the City and surrounding community without regard to its location within or outside the corporate limits of the City. The City shall pay on a monthly basis the Meter Charge as provided for in Part I of this schedule and for water consumption according to the rates set forth in Part II of this schedule.

As provided in Section 13.04.100, on and after January 1, 2023, each temporary tap user shall pay the following rate and additional charges, when applicable, for the use of water.
